Recent updates



Support for Windows 8.1 has been withdrawn.

This means that there is no technical support for TachoScan Control faults caused by the Windows 8.1 operating system.

Support for second generation of the second version (G2V2) smart tachographs

• Support for Smart Tachographs of the second generation of the second version (G2V2) was added.

Transferring of the TachoScan Control program to MS SQL

• The existing TachoScan Control database system was changed to Microsoft SQL Server. This change applies to all types of TachoScan Control licenses.

License transfer

• The way of license transfer has been changed. It is not possible to transfer a license during an upgrade from Access (6.6.9 and lower) to MS SQL (7.0.0 and above). In such a situation, you must first update the program to the MS SQL version (7.0.0), and then transfer the license.

New language version of the program

• Spanish language version of the program in BETA version was added.

(menu: Settings -> Program settings)

The option to choose the Spanish language was added (Select program language and tariff).

Separation of functions from languages

- Functions were separated from languages, allowing a given inspection to work in more than one language within one organization and with different default settings.
- The option of language selection and inspection has been added during the installation and updating of the TachoScan Control. program.

(menu: Settings -> Program settings)

• In the main settings window, the ability to change the program and inspection language has been added. Changing the inspection results in changing the tariff and functionality.
