Generating the infringement of weekly rest in a vehicle

(menu: Settings -> Analysis settings -> Analysis)

- The option: **Generate weekly rest in vehicle infringement** was unchecked by default.

Login window

(menu: Logging into the program)

- A possibility of searching for users was added in the login window.

Roadside Check Form - Luxembourg (French language version with Luxembourg tariff)

(menu: Reports -> Roadside Check Form - Luxembourg)

- A possibility of choosing a logo that will be shown on the **Roadside Check Form - Luxembourg** was added.

Protocols - Czechia

(menu: Reports -> Protokol nákladní doprava SOD; Protokol nákladní doprava policie; Protokol osobní doprava policie; Protokol osobní doprava SOD)

- The way of filling in the protocols was changed:
 - only chosen fields can be filled in;
 - you can navigate between the fields using tab key or choosing a field with the cursor;
 - you can select a checkbox by using a space bar or the cursor.

Infringements - Sweden

(menu: Reports -> Infringements and manipulations)

- The duration for **Bristfälligt register (20 §)** and **Ej inkommet material (22 §)** infringements will not be presented in the report.

Report of lacks of place entries - Sweden

(menu: Reports -> Report of lacks of place entries)

- A new report: **Report of lacks of place entries** was added. It shows the list of lacks of place entries of countries at the beginning and countries at the end.

Report of overlaps in time - Sweden

(menu: Reports -> Report of overlaps in time)

- A new report: **Report of overlaps in time** was added. It shows the list of overlapping events of driving, other work and availability.

Record sheet view/ edit window

(menu: Record sheet view/edit window)

- A possibility of entering the periods of lacks of records was added;
- information on the entered lacks of records will be presented in:
 - disc print (disc print preview);
 - Weekly chart;
 - Monthly chart;
 - Infringements and manipulations report;
 - Lack of driver's and vehicle's records report;
 - Driver's activities in detail report.

Statistical reports

(menu: Control -> Archives -> Checks statistics for EU)

- European statistical reports were updated.

DSRC module

(menu: DSRC module)

- **DSRC module** was introduced. It allows to remotely read a tachograph from the passing car without stopping it - in order to have access to the module, you need a **DSRC licence**.

(menu: Settings -> Analysis settings -> DSRC and DSRC module -> DSRC settings)

- A **DSRC** settings tab was added in analysis settings.

(menu: DSRC module -> New control)

- A possibility of creating a new control on the basis of the selected vehicle was added.

(menu: Reports -> DSRC report and DSRC module -> DSRC report)

- A **DSRC report** was added; it allows you to export data of a chosen vehicle.

Edit control window - France

(menu: Control -> New control and Edit current control parameters and Company -> Edit)

- The length of the company name that you can enter in the **Company name** field was limited to 60 characters;
- the number of characters in the **Licence number** field was limited to 30 characters;
- the possibility of choosing **Smart tachograph** in the **Type of tachograph** field was disabled.

New reports - France

(menu: Reports -> Résumé des utilisateurs de tachygraphe numérique)

- A new report **Résumé des utilisateurs de tachygraphe numérique** was added.

(menu: Reports -> Résumé d'journe conducteur.)

- A new report **Résumé d'journe conducteur.** was added.

Editing a company window - France

(menu: Company -> Edit)

- **Postcode.**, **Place** and **Street** fields were marked as mandatory;
- **Last name** field is mandatory only for the in-depth control.


Technical in-depth control - France

(menu: Vehicle -> Edit)

- **Control date** field will be filled in automatically in technical in-depth control;
- a hint with the explanation of a given choice was added when choosing the result of the technical in-depth control.

Technical in-depth control report - France

(menu: Vehicle -> Edit)

- The option of generating the report with the possibility of closing the modal window [] was added;
- the date format on the report was changed into dd-mm-yyyy.

Infringement list - France

(menu: Reports -> Infringements and manipulations)

- A new column **P.V.e** with a possibility of checking a chosen infringement was added on the infringement list.

Report of overlaps in time - Sweden

(menu: Reports -> Report of overlaps in time)

- The option of choosing a period of time was hidden and the report will be generated for all data in the control;
- the choice of drivers for which the report is generated will not be saved and the settings in the window will be reset after closing the window.

Adding infringements manually - Sweden

(menu: Reports -> Infringements and manipulations)

- A new field **Antal Tillagg**, in which is the amount of additions while manually adding infringements, was added;
- the sum of additions will be provided in the infringement description and included in the fee for a given infringement;
- the edition of the infringement duration was enabled.

Analysis period - Sweden

(menu: Reports -> Infringements and manipulations)

- The **Period from ... till** option was selected by default in the window of generating **Infringements and manipulations** report.

File certificates - Sweden

- A possibility of displaying the certificates for the files stored in StorageSystem was added.

Require at least a 45-minute break in driving, if it includes team availability (561/2006 only)

(menu: Settings -> Analysis settings -> Analysis -> Mobility package)

- A new option: **Require at least a 45-minute break in driving, if it includes team availability (561/2006 only)** was added;
 - after enabling the option, the program requires the break with the availability in team to be taken at once.

Edit/view selected control

(menu: Control -> Edit/view selected control)

- In **Select control window** in case there are no matching controls while using advanced search, an information "no results" will be displayed.

Dividing 90h rest into 2x45h

- Dividing the rest that lasts at least 90h into two rests lasting 45h each was allowed in order to avoid an infringement.

Roadside Check Form - Romania

(menu: Reports -> Roadside Check Form)

- The rest assessment table in the **Roadside Check Form** was updated.

Romanian tariff

- The romanian tariff was updated.

Phone activation of the program

(menu: Program activation)

- In the program activation window for the standard licence, after choosing the activation via phone, the activation by entering the licence code or choosing the licence file was enabled.

New language version of the program

(menu: Settings -> Program settings)

- A possibility of choosing the French language (Morocco) was added (**Select program language and tariff**).
- Morocco was added to the list of countries in the program.

Time zones

- Time zone for Morocco was added.

Sending the control to TachoScan Control Administrator

- A control is sent when switching to another control or when you close it;

- if a control cannot be sent, e.g. due to the lack of the internet access, it will be saved and sent during the next start of the program.

Activation of TachoScan Control Administrator

(menu: Program activation)

- In the TachoScan Control activation window, the option **TachoScan Control Administrator activation** was added;
- after entering the required data, the user from TSC Administrator will be added in the TachoScan Control logging window.

Adding infringements manually

(menu: Reports -> Infringements and manipulations)

- A possibility of adding infringements manually was added on the infringement list via **Add infringements** button - the option is available only with the purchase of **TachoScan Control Administrator**.

Logging window

(menu: Logging into the program)

- The users downloaded from TachoScan Control Administrator will be added on the logging window.
