- Added messages about the lack of access to the directory when the connection to the working directory of the program is not possible in the following cases.
 - o The user starts the program for the first time.
 - o The user does not have rights to edit tracks.
 - o The user has rights to edit tracks.

Infringements

(menu: Reports -> Infringements and manipulations)

- In the infringement report, infringements under Art. 12 are now written in black.
- Amendments to the penalty have been made for companies for infringements of regular weekly rest in a vehicle.

Risk analysis of loss of good repute

(menu: Reports -> Risk analysis of loss of good repute)

- Formula for calculating the risk rating of loss of good reputation in accordance with commission regulation (eu) 2022/695. This is the so-called company rating it takes into account:
 - o the number, gravity and frequency of occurrence of infringements
 - o the results of controls where no infringement has been detected
 - o using of the smart tachographs by a road transport undertakings,

According to this formula, when calculating the degree of risk rating the results of all inspections, both at the roadside and at its premises, concluded with and without findings of infringements, carried out by the Road Transport Inspection will be taken into account

Infringements confirmed by a final decision, a final fine or a decision imposing a penalty in period of two years will be taken into account, concerning the occurrence of infringements regarding driving time, mandatory breaks and rest time for drivers, including the use of tachographs.

Recent updates



DSRC

(menu: Settings -> Analysis settings -> DSRC)

- Added the ability to highlight the last received DSRC package by adding the option *Switch* automatically to a new car after reading data from DSRC.
- New appearance of the settings.
- An option of selection of all antennas that are available for a given license has been added to the VDO GPRS antenna.

(menu: Controls menu -> DSRC)

- Information about the number of correct readings added to the summary.
- The main screen has been updated.
 - o Events requiring control are on a red background.
 - o Warnings are on a yellow background.
 - o Events that do not require attention are listed in the table below the events that require control and warnings.
- The name of the tachograph manufacturer has been added to the top bar.
- Added Start/Stop button, which allows you to start and disconnect communication with the antenna.
- Software version and battery status added to information about VDO antenna.
